**Application Fee - New Student Application Fee:** \$50.00 per student.

**Enrollment Fee - Student Enrollment Fee:** \$200.00 per student. (\$250 if paid after April 16, 2020)

### **Tuition Payment Options**

- **Full Payment Option-** Full payment of the annual tuition amount is made directly to LCA and is due on August 3, 2020. If tuition is not paid by the date due on the invoice, families may be asked to switch to a monthly payment plan.
- **Semester Payment Option-** Semester tuition payments are made directly to LCA. Half of the student's tuition is due by August 3, 2020. The other half of the student's tuition is due by January 4, 2021. If payment is not made by the due date on the invoices, families may be asked to switch to a monthly payment plan.
- **Credit Card Option-** You may pay with a credit card in the LCA Finance Office. A 3% transaction fee will be added to the total amount charged. FACTS also has a credit card option.
- **Monthly Payment Option-** Monthly tuition payments are made through FACTS Management Company. This is the most flexible payment option for our families. FACTS offers two dates per month (the 5<sup>th</sup> or 20<sup>th</sup> of the month). The tuition amount will be automatically deducted from your checking or savings account. You may choose one of the following payment options:
  - 12 Months (Payments Begin June 2020 through May 2021)
  - 10 Months (Payments Begin August 2020 through May 2021)

**All tuition balances are due by May 21, 2021. Students will not be permitted to re-enroll (or may be dropped from enrollment) for the coming school year if there is a balance after May 21, 2021. Requests for exceptions must be made in writing to the Finance Committee.**

For families who enroll their student(s) after the 2020-2021 school year begins and who choose the monthly payment option, tuition will be pro-rated and divided by the number of months remaining in the school year.

To apply for any tuition assistance, families must complete a FACTS application and/or a Medicaid Verification form. FACTS is a neutral third party that evaluates each family's application and makes recommendations to the school. This application is used to qualify students for any financial aid. Applicants are responsible for paying the application fee and for mailing all required documentation to FACTS. LCA's desire is that all families who truly want a quality, Christian education can afford to enroll their student. We encourage all interested families to complete the FACTS application. The filing deadline for the first round of awards is March 31, 2020. After this, awards will be made as information is received from FACTS until funds are depleted or State or SGO deadlines expire.
